

The WFSE represents several bargaining units at the University of Washington, one of which is the Custodial Supervisors bargaining unit last described in PERC decision 10495. This petition is being filed to add certain employees to that unit.

The employees in question are three (3) food service supervisors.


The Custodial Supervisors bargaining unit is described as follows:
"All full-time and regular part-time custodian supervisors at the University of Washington and Harborview Medical Center, excluding confidential employees, nonsupervisory employees, and all other employees."

We propose to add the following to describe the unit. *All University of Washington food service supervisors, excluding those at the Harborview Medical Center.*

The new unit description would read:

All full-time and regular part-time custodian supervisors at the University of Washington and Harborview Medical Center and *food service supervisors, excluding food service supervisors at the Harborview Medical Center*, confidential employees, nonsupervisory employees, and all other employees.

The Custodial Supervisors bargaining unit is covered by the master UW/WFSE collective bargaining agreement and is on file with the commission as 020-06/2015


