MINUTES OF THE PREVIOUS MEETING

The minutes of the previous meeting held May 5, 2016 were adopted as presented.

REPORT OF THE EXECUTIVE DIRECTOR

1. Case filings in May were lower than the previous two months. There were 60 cases opened and 71 cases closed.
2. We have filled one of the Labor Relations Adjudicator/Mediator positions. Ann Zipfel will start on June 16, 2016, in the Olympia office.
3. With the amount of cases being filed, the workload of the professional staff has significantly increased. We will be hiring a temporary legal assistant to help the professional staff.
4. The implementation of Decisia, the software that will integrate into our website and improve our decision search capabilities, is still set to go live in July.



5. The Commission moved and approved the attendance of Marilyn Glenn Sayan, Mike Sellars, Lisa Hartrich, and Karyl Elinski to the ALRA conference this year on July 16-19 in Halifax, Nova Scotia.
6. June is the last month of the first half of the biennium. There is a surplus of money in the budget from the LRAM vacancies.

COURT DOCKET

Charity Atchison reviewed the pending court cases and offered updated information where available. The monthly Court Docket is available on the agency website.

OTHER BUSINESS

Commissioners Brennan and Sayan reviewed, approved, and accepted an application for the Dispute Resolution Panel from Robin Romeo.


ADJOURNMENT
