Availability:	Grievance arbitration, mediation, fact-finding.
Constraints on Time:	None.
Current Fees:	\$1,150 per day for hearing, research, preparation of opinion and award. A hearing is any portion of a day up to eight hours. Time for research and preparation is prorated. \$1,200 per day for mediation, fact-finding.
Cancellation Fees:	If the scheduled hearing is postponed or cancelled with notice of less than ten (10) days, the per diem fee for each hearing scheduled shall be charged if another matter cannot be set in its place. For hearings scheduled for more than three (3) days, a notice period of thirty (30) days will apply.
Travel/Subsistence Charges:	Arbitrator charges mileage at the federal allowed rate. Fee is prorated for travel time over eight hours at \$90/hour. Travel time is computed on a portal-to-portal basis.
	Air transportation: actual cost of refundable coach fare.
Other Fees Charged:	There are no charges for reasonable phone, clerical or incidental office expenses.
