THIS MATTER came on regularly before the Marine Employees' Commission (MEC) on May 3, 2002, when the Inlandboatmen's Union of the Pacific (IBU) filed a request for grievance arbitration on behalf of Burt Dezihan. In its grievance arbitration request, IBU asserted that WSF unjustly terminated Grievant Dezihan. IBU requested that no settlement conference be scheduled and that the hearing be expedited.

IBU certified that the grievance procedures in the pertinent IBU/WSF Collective
Bargaining Agreement had been utilized and exhausted. In addition, the union certified that the
arbitrator's decision shall not change or amend the terms, conditions or application of said
collective bargaining agreement and that the arbitrator's award shall be final and binding.

The request for grievance arbitration was docketed as MEC Case No. 46-02.

Commissioner John Sullivan was designated to act as Arbitrator at the hearing scheduled for June 10, 2002.

During MEC's May 23rd monthly meeting, IBU and WSF agreed with Commissioner Byrne's suggestion to add discussion of the Dezihan matter to the settlement conference scheduled in two other cases on May 28, 2002.

During the settlement conference on May 28, with Commissioner Byrne's assistance, the parties reached an agreement. Commissioner Byrne forwarded the parties' signed Interim Settlement Agreement (which includes withdrawal of the grievance) to the MEC office. That agreement is appended to and becomes a part of this Order by reference.

ORDER

It is hereby ordered that the request for grievance arbitration, filed by the Inlandboatmen's Union of the Pacific on behalf of Burt Dezihan and docketed as MEC Case No. 46-02, be dismissed.
