STATEMENT OF FACTS

1. PSEU Local 519 incorporates by reference paragraphs 1-7 of the Statement of Facts in the Amended Petition in cases 129946-C-17 and 129947-C-17.
2. A majority of the supervisors in the two bargaining units currently represented by the Snohomish County Employees Association (“SCEA”) no longer wish to be represented by SCEA and desire to be represented by the Public Safety Employees Union Local 519.
3. There are currently eight supervisors working in the North Campus SCEA bargaining unit, and four supervisors working in the South Campus SCEA bargaining unit.
4. After Snohomish County 911 (“Sno 911”) moves all of its operations to the North Campus, there will be 12 supervisors working shoulder to shoulder.
5. PSEU Local 519, SCEA, and Sno 911 all agree that the supervisors share a community of interest, and that a bargaining unit comprised of supervisors employed by Sno 911 constitutes an appropriate bargaining unit for purposes of collective bargaining.
6. Neither SCEA nor Sno 911 opposes this severance petition.
