### MINUTES OF THE PREVIOUS MEETING

The minutes of the previous meeting held on August 7, 2018, were adopted as presented.

### REPORT OF THE EXECUTIVE DIRECTOR

Charity Atchison provided the following report on Mike Sellars' behalf:

1. Andy Lukes is resigning from his Labor Relations Adjudicator/Mediator position. He will begin working for a private law firm on October 1.
2. The agency's focus has primarily been on teacher mediations. At the time of this meeting, PERC had received 37 requests, and Mike was mediating with Battleground School District. Teachers in 14 school districts had gone on strike; eight of those groups had reached agreements. The commissioners expressed their appreciation for the staff's great work on the teacher mediations.

COMPLIANCE DOCKET

*Kitsap County*, Case 128968-U-17. Dario de la Rosa recommended that the Commission accept compliance in this case on behalf of Compliance Officer Emily Whitney, who was mediating with Tumwater School District at the time of this meeting. Dario provided an overview of the examiner's decision and the employer's actions to achieve compliance. The Commission accepted compliance, and the case will be closed.

COURT DOCKET

Charity Atchison reviewed the pending court cases and provided updated information where available. Pending Commission cases that have been appealed to court are available on the agency website.

COMMISSION DOCKET

The Commission went into Executive Session for deliberation on pending cases before the Commission.

The October meeting is cancelled. There being nothing further to come before the Commission, the public meeting was adjourned.
