ORDER REVOKING CERTIFICATION

The International Brotherhood of Electrical Workers, Local 483 (union) represents a bargaining unit of utility foreman and utility serviceman positions who work for the City of Fircrest (employer) public works department. This agency did not certify the bargaining unit and it appears that the collective bargaining relationship between the employer and union was established through voluntary recognition. Additionally, this agency has not modified the bargaining unit through a unit clarification proceeding.

On June 28, 2019, the union filed a written disclaimer of all representation rights concerning the utility foreman and utility serviceman bargaining unit, effective immediately.

ORDER

The International Brotherhood of Electrical Workers, Local 483 requests to disclaim interest in the utility foreman and utility serviceman bargaining unit in the City of Fircrest public work department is granted.
