Appendix A

Unit Scope -- Washington State Nurses Association and WhidbeyHealth

This petition seeks to add four registered nurses with the job title "House Supervisor" to an existing bargaining unit of approximately 137 registered nurses at WhidbeyHealth.

## **Existing Bargaining Unit Scope**

Article 1 ("Recognition") Section 1 ("Bargaining Unit") of Collective Bargaining Agreement between WSNA and WhidbeyHealth:

"The Employer recognizes the Association as the sole and exclusive bargaining agent for, and this Agreement shall cover, all full-time, part-time and per diem registered nurses employed by the Employer as Resident Nurse, Staff Nurse, and Charge Nurse, at its Hospital, Home Health Agency, Hospice, and Community Clinics and Provider Practices; excluding Management Officials, Nursing Managers/Directors and other supervisors and all other employees."

## **Proposed Bargaining Unit Scope**

"The Employer recognizes the Association as the sole and exclusive bargaining agent for, and this Agreement and the Collective Bargaining Agreement (Agreement) shall cover, all full-time, part-time, and per diem registered nurses employed by the Employer as Resident Nurse, Staff Nurse, Charge Nurse, and House Supervisor at its Hospital, Home Health Agency, Hospice, and Community Clinics and Provider Practices; excluding Management Officials, Nursing Managers/Directors, other supervisors, and all other employees."
