This change of representation petition is jointly submitted by the Washington Federation of State Employees AFSCME Council 28 and the Washington State Council of County and City Employees AFSCME Council 2.

Leaders from WFSE Council 28 and WSCCCE Council 2 are AFSCME affiliated Unions and have determined through internal jurisdictional conversations that Council 2 would be a more appropriate bargaining representative for this group of conservation district employees.

On October 12, 2022, the Thurston County Conservation District employees conducted an election and chose to have WSCCCE Council 2 assume representative duties for the employees.
